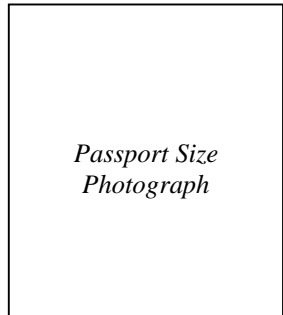

6. That in case of my son's/daughter's/ward's progress in studies is uniformly poor in the institution, his/her studies are liable to be terminated by issuing Transfer Certificate.
7. That in case my son/daughter/ward becomes a scholarship holder and does not show required progress, the scholarships are liable to be cancelled and that if my son's/daughter's/ward's conduct and character are not good, these will be cancelled summarily.
8. That my son/daughter/ward is aware that breach of discipline and rules or bad conduct will also entail forfeiture of seat in the institution, in addition to such other proceedings which may be taken against him/her.
